We received notification that the Province will no longer sole source this grant and it will have to go to RFP. Bailey noted that this partnership began in 2004 as a true partnership but has moved to a more contractual relationship in the last few years. P. Bailey notes he and staff will meet next week to discuss SAPL response. The contract is for provision of career and job search-related services to St. Albert and area. SAPL is the only Alberta library funded to provide career and job search-related services.
